- 6. Should you have any queries or dispute any Debit item, please contact WIRES in the first instance.
- 7. Your records and account details will be kept private and confidential. The information will only be disclosed if requested by yourself or the financial institution if a claim is made of an alleged incorrect or wrongful debit.
