



Origins of The Myer Foundation





The Myer Foundation was established in 1959 by Sidney Myer's sons, the late Kenneth Myer AC DSC, and Baillieu Myer AC, as a way to support initiatives and new opportunities arising from contemporary issues. The Myer Foundation was endowed through Kenneth Myer's estate following his death in 1992.

The Myer Foundation President's Address

Having spent several years away from a direct governance role at The Myer Foundation, returning to it at such an extraordinary time has been a deeply encouraging and inspiring experience. The breadth of input to TMF's work is remarkable. There is strong family engagement through the board and Committees as well as through the voices of individual members, there is the depth of knowledge brought by our non-family Committee experts and Directors, and there is the tireless contribution of the staff, led by our dynamic and energetic CEO, Leonard Vary, which plays a key role in the success of our work. It is a collaborative environment that, through purposeful joint effort and direct engagement across many community sectors, creates something greater than the sum of its parts. Our version of family philanthropy – driven by the needs of our community, by excellence and expertise, by consultation and cooperation – has evolved over time and it is a great privilege to be back in the thick of it.

Collaboration extends well beyond the constitutional edges of The Myer Foundation. I have already seen the clear benefit of our working closely with the Trustees of the Sidney Myer Fund on matters of universal and urgent import like climate change and mental health, the circumstances created by the pandemic and on programs such as the Kenneth Myer Innovation Fellowships. I thank SMF Chairman Andrew Myer AM and his fellow Trustees for this highly collaborative approach that is beneficial for the communities we serve as well as to our internal processes.

I want to thank The Myer Foundation board who make my job all the more enjoyable, and to particularly acknowledge Emily Myer as TMF Vice President. In FY21, the board farewelled, tearfully, it must be said, Mary Vallentine AO, who had served with us for many years. We also farewelled the meticulous mind of Professor John Daley AM but are fortunate to have the equally meticulous Dr John Spierings joining in his stead.

I have inherited a great deal coming into this role. Immediate past President Martyn Myer AO's resolve in moving 100 percent of The Myer Foundation's corpus to ESG (environmental, social, governance) investments leaves a progressive and sector-leading legacy. I also see the imprint on TMF – and on myself - of the leaders who have come before me and those who will follow. The Presidents, the Convenors. the boards, the CEOs, the committee members whose perspectives I have learned from, whose styles I have absorbed. Our family and this institution are beautifully entwined.

Of course, not every family member will like everything we do. But I am confident that every family member can be very proud of something that The Myer Foundation has done in FY21. This annual report helps facilitate that and gives visibility to the breadth of our grantmaking and community engagement. It is an important instrument of transparency, but it is also a record of our shared achievements, from the smallest grant to the grandest vision.

As you will see, there has been significant grantmaking in key areas. It has been encouraging to see the broad and passionate board, staff and membership engagement on the issue of climate change and the support arising for both existing and new climate-related initiatives. The

importance of human, civil and legal rights has been put in stark relief recently, as has the significance of good mental health. Many more people in our community have needed support over the last year than ever before, but the resilience of the not-for-profit sector in working to meet that need has been just as exceptional.

The Myer Foundation is now well advanced in its current strategic period and the attention of the board is naturally turning towards the future. As we examine the landscape of need, of circumstance and of competing grand narratives, we will ask ourselves and others how The Myer Foundation can best help Australia to flourish in the years to come.

The Myer Foundation CEO's Introduction

FY21 marked the midpoint of our current five-year strategic period. It is wonderful to see the very substantial progress that has already been made on the strategic priorities. In some cases, we are ahead of where we expected to be at this midpoint. The global backdrop for this achievement is the immense disruption of the COVID-19 pandemic and, on a brighter note, the accelerating momentum for action on climate change.

On climate change, The Myer Foundation's ambition to transition its corpus to 100 percent ESG investment is running well ahead of schedule. This move aligns our financial resources with our mission, recognising the important role that capital markets play in decarbonising the economy. In addition, climate and sustainability initiatives now represent almost half of TMF funding.

Alongside efforts to rapidly decarbonise the economy, our nation's resilience in the face of climate change will be enhanced by the work of the newly launched Watertrust Australia Ltd. An exemplar of the capacity of philanthropy to leverage its independence and power to convene, Watertrust Australia is designed to help improve the way decisions are made about Australia's scarce and precious freshwater resources. This project was led by TMF, in partnership with The Ian Potter Foundation, through joint funding of \$10 million over ten years – funding which has now been leveraged to a total commitment of over \$31 million from a coalition of 16 philanthropic trusts and foundations.

The urgency around climate change has been reflected in strong and purposeful engagement from fourth generation members of The Myer Foundation on this matter. That engagement is already bearing fruit, with greater resources being directed towards climate action through collaborations with the Sidney Myer Fund. It is also part of a broader shift, with several G4 members joining Committees for the first time.

As a philanthropic entity, The Myer Foundation is accustomed to putting money to work in the community. It is less common for that money to do its work and then return to us, multiplied many times, for its next assignment. Yet that is exactly what has happened with HireUp, which offers a platform allowing people with disabilities to connect with support workers online. The Myer Foundation provided seed investment in HireUp in 2015 because of our confidence in Kenneth Myer Innovation Fellow Jordan O'Reilly's idea. The positive social impact HireUp is having has been accompanied by stellar financial performance, so we have been able to sell a modest part of our stake in the social enterprise and recoup very materially more than our initial investment. The proceeds of that investment can now be put towards further ambitious grantmaking in the years to come.

My thanks to the dedicated and sector-leading staff of The Myer Foundation who spent much of FY21 at home dealing with the vicissitudes of restrictions without missing a beat. In those few months when we were at the office, they also managed to pack down more than a decade of history at Bennetts Lane and reconstitute the office in our new home at 171 Collins St, immediately adjacent to Myer Family Investments. Speaking of history, the efforts of long-serving staff members Dr Neal Harvey and Jenny Kelly, who both left the office at the end of 2020,

are now part of TMF lore – a special thanks to them. And the warmest of welcomes to new staff members Carl Nilsson-Polias and Madeleine Livingstone, whose talents round out our team to perfection.

In what was, by any measure, a year with its share of highlights and challenges, one of the steady and resolute fixtures on my horizon has been Rupert Myer. His presidency of The Myer Foundation has only just begun, but it has been an immense pleasure to engage with him in every aspect of our work together. His calm, patient and thoughtful disposition is complemented by a sharp clarity of vision and a decisiveness that moves things forward, and at the pace that these times require.



Australia is the driest inhabited continent with highly variable rainfall and run-off. Long-term and sustainable management of our waters and catchments is essential.

Yet, just when climate change, population growth and the ongoing degradation of our nation's natural capital assets require policy change, debates over the use and management of Australia's waters and catchments are becoming increasingly difficult.

The Myer Foundation and The lan Potter Foundation shared a vision to create a new, independent and authoritative


centre that can rebuild trust and work collaboratively with all stakeholders to find common ground on water and catchment policy reforms.

A coalition of 16 philanthropic funders committed to investing in a national and fully independent centre focused on helping improve the way decisions are made about water and catchments across Australia. That centre has now been incorporated as Watertrust Australia Ltd, led by chair Kathryn Fagg AO, with Rod Marsh acting as Interim CEO before inaugural CEO Nick Austin commenced in the role in September 2021.

Watertrust Australia will work with communities, First Peoples, farmers, landowners, agricultural and environmental organisations, industry, researchers and experts, land and water managers, and federal, state and local politicians, governments and elected representatives. Its independence allows it to approach current and future water and catchment policy challenges as an honest broker, seeking better decisions, not predetermined answers.

Climate Change



Responding to climate change is the great existential challenge of our time and is rightly one of the two abiding themes of the current (FY19–23) strategic plan.

We can readily see that our lands, waters and skies are feeling the impact of global warming, but its force moves well beyond the elemental. Climate change has flow-on effects for the economy, food security, health systems, social inequity, human rights, and the arts.

Such an all-encompassing threat requires a holistic response. Our philanthropy is informed by the United Nations Sustainable Development Goals and we recognise the imperative of the United Nations Paris Agreement to limit global warming to 1.5 degrees Celsius. Urgent action is required now to at least halve emissions by 2030 and achieve net zero by 2050.

The Myer Foundation is pursuing a suite of strategies – a portfolio approach – to advance our commitment to environmental sustainability. Grantmaking supports organisations taking discrete but complementary approaches to effecting systemic change, as well as direct action through the investment of The Myer Foundation's own financial resources in ESG (environmental, social, governance) assets.

Sustainability & Environment Program

The grantmaking of the Sustainability & Environment Committee in FY21 was set against a backdrop of growing urgency for addressing climate change. As the recent Intergovernmental Panel on Climate Change Physical Science Basis report attests, climate change is here and worsening. Limiting global warming by achieving net zero global emissions by 2050 is not something that can happen in decades to come. The process needs to start now. With every day of inaction that passes, this vitally important global target becomes harder and harder to achieve.

The urgency of the climate challenge and the criticality of acting immediately, coupled with the strength of the organisations being considered for funding, compelled the Committee to fast-track the FY21 grantmaking round. The Committee was delighted that three organisations taking discrete but complementary approaches to climate action were supported: Farmers for Climate Action, The Next Economy and Original Power.

Farmers for Climate Action is a national organisation committed to building a farmer-led movement for

climate action. Agriculture accounts for 13 percent of Australia's emissions and farmers manage almost 60 percent of Australia's land and food production systems. Farmers speak to their own significant rural community but also have an important role to play in a national bipartisan approach to net zero emissions.

The Next Economy supports government, industry and regional communities to manage the transition away from carbon-intensive industries towards clean and healthy local economies. By facilitating local solutions and public discussion on climate action through the lens of economic growth, The Next Economy helps to take often divisive politics out of the conversation.


Original Power builds the capacity of Aboriginal and Torres Strait Islander people to protect their country, culture and communities. The organisation works with Indigenous communities and Traditional Owners, who manage over 40 percent of Australia's land and sea (under Native Title and Indigenous Land Use Agreements) and has a focus on developing renewable energy opportunities.

Thanks to the Sidney Myer Fund, an additional \$300,000 per annum has been made available for the Committee's grantmaking through to the end of this strategic cycle, allowing for three organisations to be supported, rather than the usual two. We are grateful to the Sidney Myer Fund Trustees for their support, both moral and monetary, this year and in the years to come.

Our thanks to fellow Committee members Martyn Myer AO, David Shelmerdine, John Connor and Dr John Spierings for their work in FY21, along with Lindy Shelmerdine and Adelaide Badgery, who we farewelled in February and May 2021, respectively. We also welcomed G4 members Lilly Myer and Nick Shelmerdine, who commence their roles in FY22. We would like to thank CEO Leonard Vary and Program Manager Jane Thomas and the whole management team for their support and assistance over the past year.

Kenneth Myer Innovation Fellowships

The Kenneth Myer Innovation
Fellowships give Australia's top social
and environmental innovators the
unique opportunity to spend a year
pursuing a groundbreaking idea.
The Myer Foundation supports one
Fellowship each year, within the themes
of sustainability & environment or
human, civil & legal rights, alongside
two Fellowships supported by the
Sidney Myer Fund. In recent years, there
has been an enhanced focus on ideas
that address climate change.

Over time, Fellowship projects have sought to develop new approaches to reduce homelessness, strengthen the Australian climate movement, establish sustainable ocean farming models, and improve the conditions in Australian immigration detention centres. One of the great success stories is HireUp – founder Jordan O'Reilly was a 2015

Fellowship recipient and the for-purpose enterprise, which empowers people with a disability to choose and engage with disability workers online, is now a critical player in how the National Disability Insurance Scheme functions in Australia.

In FY21, the Fellowship supported by The Myer Foundation was awarded to Rebecca Scott OAM. Already a leading social entrepreneur with STREAT, Rebecca now aims to harness food social enterprises to build an expansive Victorian food-bowl starting in the city. The initiative is multifaceted and involves many other individuals, groups and organisations in collaboration with each other. Rebecca has already secured almost \$4 million in funding to support these collaborative initiatives.

Each year the Fellowships are keenly sought after and this year was no

different, with over 253 Expressions of Interest submitted. As Co-Convenors we are joined and supported in the task of selecting the Fellows by a stellar Committee, which in FY21 comprised Dr Anna Foley, Edwina Myer, Professor John Daley AM, Jan Owen AM and Kathryn Fagg AO. We are grateful for their insightful contributions and pay special tribute to former Co-Convenor Dr Foley and Professor Daley, both of whom stepped down at the end of June 2021. Our thanks also go to the members of the Kenneth Myer Innovation Fellowship Support Panel, Oliver Roydhouse, Clare Harding and Quentin Miller, and to The Myer Foundation CEO Leonard Vary and team.

Mental Health Program

The Mental Health Committee was formed at the 2013 Retreat for fourth generation Myer family members. Delegated with the authority to act on behalf of the G4 cohort, the Committee's grantmaking focus rests on upstream interventionist activities and programs in the youth mental health sector. Each year, the Committee seeks to balance its grantmaking across program delivery and research initiatives and looks to award multiple grants in support of large and small organisations.

In FY21, the Committee reflected on the mental health impact of the COVID-19 pandemic and considered the findings of the Productivity Commission inquiry into mental health and the Royal Commission into Victoria's Mental Health System. These two reports are closely aligned in their recommendations and the Committee discussed how philanthropy can best assist in realising these reforms at a government level. Insights from experts were considered, and three key needs were identified: better advocacy to government, additional support for those whose mental health needs are too complex and enduring for primary

care services but not considered severe enough for treatment in public specialist clinical mental health services, and capacity building for peer support services from people with lived experience of mental illness and peerled organisations.

As a result, the Committee took the opportunity to temporarily set aside its usual focus area of youth mental health and focus its grantmaking on organisations that addressed those needs. Makeshift Creative educates adults around mental wellbeing through creativity, promoting non-clinical community-based interventions that put individuals at the centre of their mental health self-care strategy or recovery journey. Australians for Mental Health is leading advocacy efforts around greater funding and more effective service provision at both the State and Commonwealth government levels. The Big Feels Club is an exemplary peer support service founded in Melbourne in 2017 that provides mental health resources, including articles, podcasts and digital self-help tools for people experiencing long-term psychological distress.

We would like to thank our fellow Committee members Laura Richards, Nell Golden, Jessica Myer, Jemima Myer, and the irrepressible Kristen Douglas for their hard work and good counsel. Further thanks to Leonard Vary, Neal Harvey, Carl Nilsson-Polias and all the staff for their assistance with our grantmaking activities this year. And special thanks to the Sidney Myer Fund Trustees who matched the Committee's funding for The Big Feels Club, giving this wonderful organisation the stability of two years' funding.
