Chairman's Address

Whilst this year has seen a return to more normal weather patterns in some parts of Australia after the horrific fires and droughts of the previous summer, community concern over climate change and the need for action has reached an all-time high.

Regrettably, the Australian government doesn't feel the same level of urgency and thinks slogans such as "the Australian way" and "technology not taxes" are sufficient to manage the emerging reality of the climate crisis.

While states such as NSW under the environmental (and now treasury) leadership of Matt Kean are boldly leading on commitments to climate change action, the recent COP meeting in Glasgow was a low point as far as the international perception of Australia. Whilst the Prime Minister was reportedly personally moved by Bill Gates' recent book on climate change, there is little real action by his government on the issue. Vested interest, principally the fossil fuel industries, continue to be able to influence and slow down this time critical transformation.

However, I remain positive Australia will not be left behind on the energy transformation because of progressive state governments of both political persuasions and our dynamic business community.

Over the life of the Purves Environmental Fund (PEF) raising the awareness of and solutions on climate change have been a core funded area. Initially supporting Tim Flannery with his books on climate change, we have funded the establishment and ongoing operation of the Australian Youth Climate Coalition, the Climate Council and Farmers for Climate Action, as well as numerous awareness campaigns including WWF's Earth Hour.

Not only is there now overwhelming support for climate action in our communities (75%+ of Australians see climate change as a serious issue), but business is now leading the charge. Many businesses see huge opportunities available based on the emergence of the new green industrial revolution. As Mark Carney, the former head of the Bank of England, often notes, being part of this transformation offers the greatest opportunities in a lifetime for young people going into commerce.

While climate impacts are all pervasive on the environmental front, the PEF continues to support other critical environmental efforts ranging from preserving the Great Barrier Reef to improving water reform, helping protect our unique wildlife and ensuring better environmental laws and enforcement of existing laws.

Although climate change is a critical factor there is a fundamental need to achieve improved environmental outcomes and processes in these other important areas as well.

During 2020-21, a continuing outstanding success story has been the national merger of Environmental Defenders Office (EDO). The PEF is a cornerstone funder providing capacity building resources to support this merger of previously state-based organisations to come together as ONE national EDO. This has given the EDO the depth and breadth of talent plus the financial clout to stand up and support public interest in areas of climate, biodiversity, water, and law reform. This is particularly critical for regional and Indigenous communities that face fossil fuel developments that have far reaching negative social as well as environmental impacts.

The year also saw the PEF pass the \$20 million gifting mark, funding some 290 initiatives since it was established. At times it has felt like the challenges are so overwhelming and progress is two steps forward and one step back. However, I do feel we have made a difference in better protecting our natural world, a world that we increasingly realise we must live in harmony with, if humanity is going to survive and prosper into the future.



Since the establishment of the PEF, I have been fortunate to have the input of Ian Pollard AM, Richard Gelski, Geoff Brunsdon AM, and more recently my son, Rhett, as Directors. I would like to thank them for their continuing contribution. In addition, I'd like to thank Erika Hosoyama who manages the fund.

Let's hope the Glasgow COP Climate meeting provides a turning point in addressing climate and moving humanity to a more sustainable basis.

Vision

The PEF's vision is an environmentally sustainable world in which biodiversity is preserved.

Mission

The mission of the PEF is to advance, primarily through education of individuals and organisations, environmental sustainability and preservation of biodiversity.

Objectives

The PEF grants gifts (funds) to enable and empower others working towards environmental sustainability and preservation of biodiversity.

Since its establishment, the Wentworth Group has built a national reputation for practical, high quality, scientifically-based policy reforms to improve the management of Australia's land, water and biodiversity assets. Central to the success of the Wentworth Group is its ability to harness the voluntary assistance from highly qualified people who contribute their time, expertise and reputations to the development of public policy reforms.

Water Reform

The Wentworth Group has maintained a strong interest in the sustainable management of Australia's water resources. Its focus in recent years has been in the Murray-Darling Basin where the Australian government has committed a major reform package, which included the Murray-Darling Basin Plan and a \$13 billion investment to restore the health of the Basin.

Given the scale of the reform and the large public investment, the Wentworth Group has invested significant resources into the technical and institutional changes needed to ensure these reforms deliver long term outcomes for the people and ecosystems in the Basin.

In August 2020, the Wentworth Group released a research paper entitled *Assessment of river flows in the Murray-Darling Basin: Observed versus expected flows under the Basin Plan 2012-2019*. Flows at gauges at 27 sites across the Murray-Darling Basin were assessed to judge the impact of the \$6.7 billion the Commonwealth Government has spent recovering water under the Murray-Darling Basin Plan to increase river flows. The Wentworth Group found that 22% of the water that should have been in the River Murray was missing, and called for governments to investigate and address this major problem.

The largely unregulated take of water through 'floodplain harvesting' in the northern Murray-Darling Basin is increasing rapidly and threatens freshwater ecosystems, downstream communities and the Basin Plan. The Wentworth Group contributed evidence to NSW Government deliberations and NSW parliamentary inquiries into floodplain harvesting. Based in part on its evidence, the NSW Legislative Council twice disallowed inadequate regulations proposed to govern the practice. The Wentworth Group is proposing better ways to regulate floodplain harvesting to ensure that downstream wetlands, towns and other water users receive adequate water.

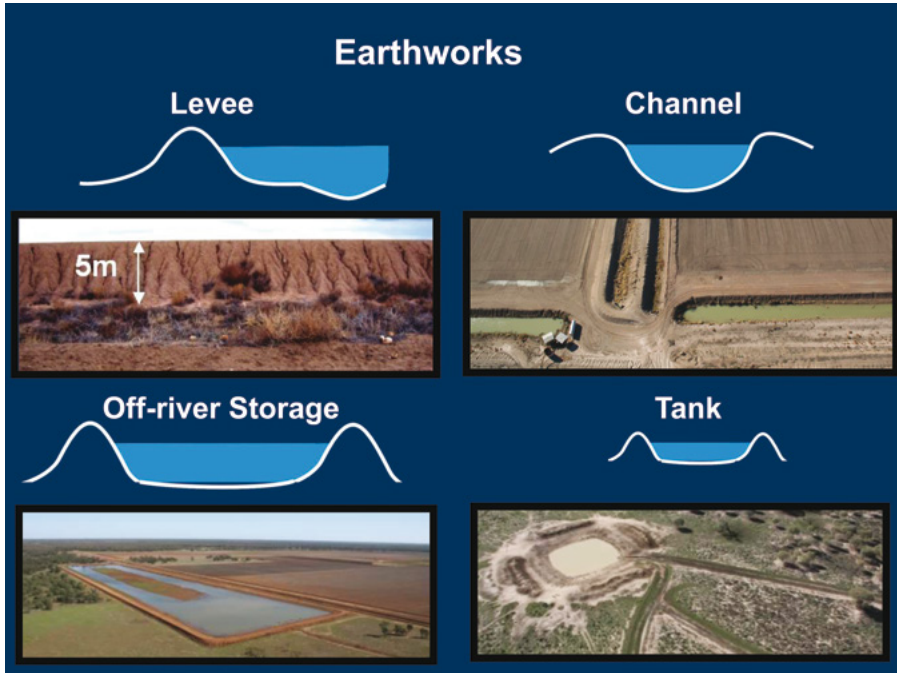


Figure 1: Four examples of flood works: levees, channels, off-river storages and tanks. Other floodplain earthworks can also be used such as flooding and ponding banks, protective earthworks, roads etc.

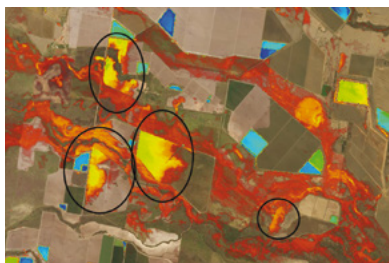


Figure 2: Satellite imagery showing water flows on floodplains including earthworks intercepting and restricting flow paths (image from Digital Earth Australia's Water Observations from Space)

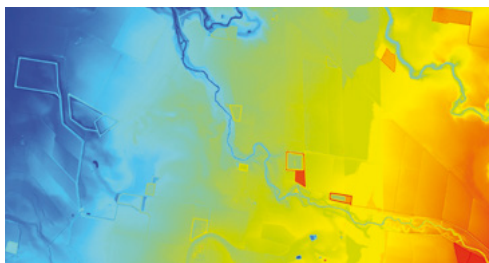


Figure 3: Digital elevation map of a floodplain showing the areas of higher (red) and lower (blue) elevation. The engineered structures protrude out of the relatively flat floodplain (image from Google Earth Engine)

To improve water management policies nationally, the Wentworth Group contributed extensively to the Productivity Commission's 2020-21 National Water Reform Review. A number of our solutions were adopted by the Commission in their recommendations for reforms to the Federal Government, including recommendations directed at: improving the integrity of water governance; regulating the 'interception' of water through changed land uses; and requiring proponents of new water infrastructure developments to undertake rigorous cost-benefit analysis.

Landscape Conservation

The statutory review of Australia's environmental laws provide a once-in-a-decade opportunity to help bend back the curve of biodiversity decline in Australia, while simultaneously simplifying and streamlining assessment and approval processes for business. The Wentworth Group proposed changes that can deliver better environmental outcomes while reducing regulatory burden and duplication for business.

However, government proposed amendments threaten to weaken Australia's national environmental law, the *Environment Protection and Biodiversity Conservation Act 1999*. The Wentworth Group provided evidence and engaged senators and the Federal Minister regarding proposed amendments that would streamline environmental approvals and adopt weak standards. To date, the Wentworth Group's efforts have helped persuade key senators not to weaken the environmental law.

In 2021-22, the Wentworth Group will focus on mapping and reporting on changes in native vegetation composition, and by quantifying the interventions needed to restore all of Australia's environment to a moderate degree of health.

In September 2019, the eight state-based EDO relaunched itself as one merged national organisation, becoming the largest environmental legal centre in the Australia-Pacific dedicated to protecting climate, communities and shared environment by providing access to justice, running groundbreaking litigation and leading law reform advocacy. To aid with the merger process, the PEF is supporting EDO futureproof itself financially by building and growing a diverse and stable income base that allows them to operate a larger organisation.

Initiative-based Funding

Apart from capacity building, the PEF also provides initiative specific funding. These are provided to organisations and initiatives that not only closely align with our charitable purposes, mission and vision but also our focus areas of support. The funding focus areas are periodically reviewed in accordance with our latest strategy and direction that reflect the environmental movement and gaps in effecting changes. During 2020-21, our focus funded areas were **improvement in landscape and water management, climate change action plan and renewables advocacy**, and **species loss from habitat destruction**.

Improvement in Landscape and Water Management

Greening Australia works to solve bold and complex environmental problems through conservation on a massive scale using science-based and innovative programs and projects.



In 2020-21, the PEF supported Greening Australia engage an external consultant to conduct a scoping study on proposed ecological and farming regeneration project in the Monaro region in NSW. The study identified the most urgent priorities and the processes that would trigger change required to shift to a more regenerative practices and preservation of natural capital in the region. Follow-up steps of this exercise is currently being explored.



Climate Change Action Plan and Renewables Advocacy

In 2020-21, the PEF supported ClimateClever provide free subscription to 50 schools across Australia for 12 months to help schools and students become leaders in sustainability and climate action.

In 2020-21, the PEF supported Solar Citizen's campaign in Queensland aimed at telling positive renewables jobs stories in the region and build support for renewables amongst business leaders and community across the region. During this period the Queensland state government committed to establishing Renewable Energy Zones, and increasing investments in publicly-owned large-scale renewable energy generation.

The PEF has been supporting a campaign run by an alliance of NGOs to stop excessive deforestation in Australia since 2017. During 2020-21 the alliance continued its focus in Queensland as it



remains to have the highest rates of deforestation in Australia even after the strengthening of vegetation management laws in 2018 as a result of alliance's work. The alliance also continued to engage with the beef industry, which is one of the major contributors to tree-clearing in Queensland. Furthermore, it ran a campaign in Northern Territory in response to increased land clearing threats from proposed cotton industry expansion. Key activities and achievements during 2021-21 include:

- Ongoing engagement and advocacy with beef industry led to McDonald's Australia to commit to stop selling beef produced on Queensland properties on which primary forest was cleared from December 2020 onwards, and Woolworths to commit to sustainably source beef and soy in its brands and soy in livestock feed that do not contribute to deforestation by 2025;
- Queensland Premier directed in writing in late 2020 the new Environment Minister to implement the following objectives relevant to land carbon and land clearing (as well as land restoration and koalas):
 - Oversee the development of the Climate Action Plan 2020-2030, through consultation with industry and community, and generate actions to reduce emissions and support sustainability initiatives.
 - Oversee the implementation of the Southeast Queensland Koala Conservation Strategy 2020-2025.
 - Continue to work with the Treasurer and Minister for Investment and stakeholders to implement the flagship \$500M Land Restoration Fund.

- The Alliance acted as the eNGO representative on the Queensland Koala Advisory Council, which resulted in a Koala Conservation Strategy and the strongest koala protections Queensland has ever seen. These strong new regulations prohibit the clearing of over 330,000 hectares of koala habitat areas in southeast Queensland.
- The Alliance ran a rapid and sharp campaign to highlight the threats of increased land clearing and damage to the Northern Territory's wild rivers from a cotton industry expansion.

The Invasive Species Council campaigns for better laws and protections for native plants and animals from weeds, pests and feral invaders. The PEF is supporting the Reclaim Kosci campaign led by the Council to ensure that the NSW government puts in place a strong management plan that begins action to protect the environmental values of Kosciuszko National Park by significantly reducing horse numbers and repairs the damage created by 14,000 horses.

The Colong Foundation for Wilderness is Australia's longest-serving community advocate for wilderness. It promotes the idea of natural areas exist for nature's sake and wilderness as a place where nature has primacy, a place where nature can flourish in glorious diversity. The PEF is supporting a grassroots community campaign led by Colong Foundation to stop the raising of Warragamba Dam wall in the Great Blue Mountains World Heritage Area, which would result in destruction of 65 km of wilderness rivers and inundation of 4,700 hectares of land impacting many listed threatened species.

The PEF contributed to Taronga Conservation Society's Wild Futures project, which will establish Specialist Teaching Veterinary Hospitals in Sydney and Dubbo, NSW. The project aims to not only provide urgently needed additional space for the increasing demand on

Taronga's services for treatment, surgeries, rehabilitation and quarantine, but also enable widespread training and upskilling of wildlife carers, students and veterinary practitioners across the country.

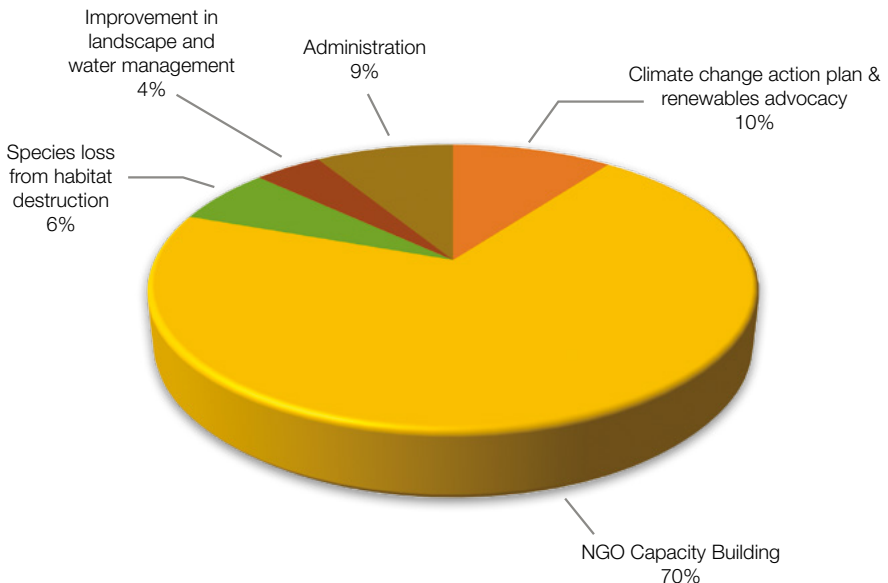
Financial Summary

The diagram below depicts typical expenditure broken down by a generic categorisation.



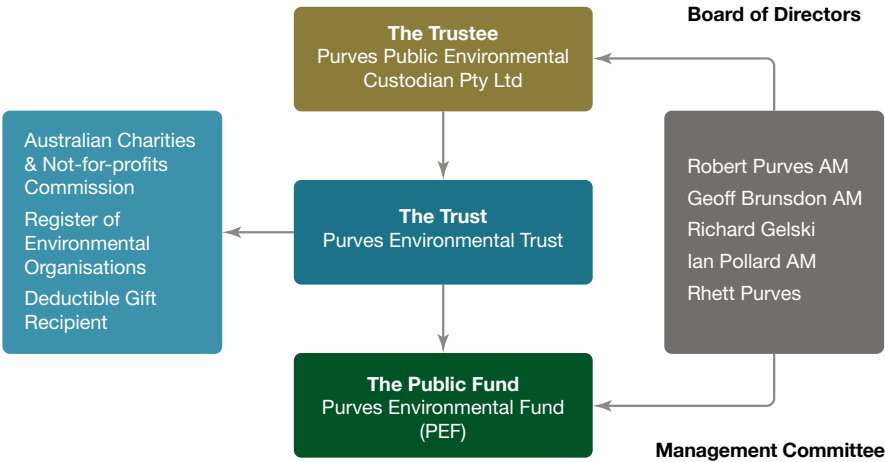


Governance

Fund Structure

The Purves Environmental Fund is the Public Fund of the Purves Environmental Trust. The Trustee of the Trust is the Purves Public Environmental Custodian Pty Limited (the Trustee Company), which is a company limited by shares. The Purves Environmental Trust was founded in 2004 by Robert Purves AM.

The PEF operates on a not-for-profit basis. The Trust is registered on the Register of Environmental Organisations and is a Deductible Gift Recipient (ABN 78 930 366 807). It is also a registered charity with the Australian Charities and Not-for-profits Commission.



Board of Directors

The Board of Directors of the Trustee Company governs the Purves Environmental Trust. The Board members also form the Management Committee of Purves Environmental Fund (PEF). The Board sets the strategic direction and policy of the PEF, approves the annual budget and regularly reviews the operations and financial status of the organisation. In their capacity as members of the PEF's Management Committee, the Board also approves PEF's support for individual projects. The Board ensures compliance with the Corporations Act and Income Assessment Act, as well as the requirements of the Australian Securities and Investment Commission and Australian Charities and Not-for-profits Commission.

The Directors are:

Geoff Brunsdon AM is a professional company director and is currently Chairman of Sims Limited, Metlife Insurance Ltd and Dexus Asset Management Ltd. In 2009, he retired as Managing Director and Head of Investment Banking of Merrill Lynch International (Australia) Limited. Geoff was a Member of the Takeovers Panel between 2007 and 2016, he is a Fellow of the Institute of Chartered Accountants, a Fellow of FINSIA and a Fellow of the Institute of Company Directors.

Richard Gelski is a consultant at corporate law firm Johnson, Winter & Slattery. He has over 40 years' experience as a university academic, barrister & solicitor. He sits on a number of private & public company boards as well as a number of Private Foundations.

For the past twenty years Richard has provided pro bono work to charitable funds and created a variety of private charitable foundations.

Ian Pollard AM is a company director and actuary. He is currently Chairman of RGA Australia and the Wentworth Group of Concerned Scientists. Ian was previously Chairman of Billabong International, Corporate Express Australia and Just Group. Ian is also an executive coach with Foresight's Global Coaching. A Rhodes Scholar, Ian has written a number of books and papers, principally in the areas of corporate finance and human development. He has also been active in a number of not-for-profit organisations, principally involved with youth.

Robert Purves AM is a businessman and an environmentalist. He is a founding member of the Wentworth Group of Concerned Scientists, a Director of Climate Council of Australia, a Patron of the Lizard Island Research Station, and a Governor of Australian Youth Climate Coalition. Robert is the immediate past President of WWF-Australia and a former board member of WWF-International. In 2008 Robert was appointed a Member of the Order of Australia (AM) for service to conservation and the environment. Robert was also awarded the Australian Geographic Society's Lifetime of Conservation Award in 2015.

Rhett Purves is a corporate strategist, who has led large-scale business transformation, growth and scale-up. He holds a Bachelor of Business (Hons), Finance.
