Certificate IV in Disability





Descriptor

This qualification addresses work in residential group homes, training resource centres, day respite centres and open employment services, other community settings and clients' homes. These workers apply knowledge and skills gained through qualifications and/or previous experience to provide training and support to people with disabilities to enhance their ability to achieve greater levels of independence, self-reliance and community participation, report to service managers and may liaise with health professionals and other service agencies. Employees in this field may work without direct supervision and may be required to supervise and/or coordinate a limited number of lower classified workers. This is a great course for anyone wishing to upgrade their qualifications from a Certificate III level or to enter the Disability Services sector at a senior level.

Mode of delivery

This course is delivered to domestic students in face-to-face classes of 20 hours per week or mixed mode or on-the-job.

A work placement component of 120 hours is included and will be at a Collegeapproved facility. The work component may be paid or unpaid.

Assessment and Monitoring

Assessment for this qualification is by written reports, case studies, projects, role plays, written assessments and practical assessments in a designated workplace. Monitoring will take the form of monitoring of computer-based activities and telephone/Skype consultation.

Recognition of Prior Learning

Recognition of Prior Learning (RPL) is available to all students applying for this qualification. Conditions apply. RPL is the recognition of your current skills and knowledge acquired through prior learning from other training, work or life experience.
