

The 2019/20 Season saw the third season of the Kennedy Cup Handicap Club Swim get underway again in September. The format followed last season with weekly swims being held up until March when things had to be put

The first weekend of the new year we held our first bay to beach swim covering a distance of 950 metres which saw many members turn up to test out a different format.



First Aid Officer Report



"As the lifesaving season is nearing the closure for the 2019/20 season, I would like to thank all members for their efforts of maintaining a high standard of care with the First Aid of patients that were treated by members."



Throughout the season, we had the privilege of hosting and assisting carnivals and without hesitation, we had many members keen to assist at these carnivals and this is a testament to the volunteer base Coolum Beach SLSC has.

We have had yet another fatality free season which is a testament to the safety of our beach along with the patrolling members we have.

This season saw an increase in our capabilities for responding to trauma as we had a few trauma cases, in which patients were provided the upmost care and treatment by our members. The club incorporated a Trauma Response Kit which was successfully used in a case where a young teenager was shot by accident with a spear gun in the foot.

The implementation of the Trauma Response Kit is vital to provide high care

for our trauma patients, which in the last two years, we have seen an increase of due to the environment around the club and towards Point Perry. This kit lives on the bench in a Red bag in the First Aid Room and can be grabbed quickly and efficiently to treat patients when required. I would encourage members to look through the kit to see its contents, so they are familiar with it.

We were also very fortunate to obtain five free defibrillators from the Queensland Ambulance Service to increase our capabilities for medical incidents. These kits were installed in glass cases in common areas around the club in the gym, common room, office entrance, first aid room and a spare one ready for use for Tickle Park and surrounding area. Thanks to Mick Sell for installing these.

In conclusion, I would like to thank all

our members for writing messages on the board in the First Aid Room. This process allows for efficient re-stocking of first aid equipment and is essential for the preparedness of upcoming patrols.

I would also like to thank the club executive & management committee for their support in providing resources and allowing for the clubs' response capabilities in the First Aid area to be increased and sufficiently stocked with equipment, which ultimately benefits our members and of course, the greater community when we are treating them.



Treasurer Report



"Coming into the season as the new Treasurer has been an absolute pleasure."

The financial strength of the Club coming into this season is an enormous credit to previous committees, and it is pleasing to be able to report the continued strength.

Having completed the renovations of the members' area at the clubhouse, and construction of the new storage facility at the Coolum West property, from a financial point of view the season was about consolidating our position and setting ourselves up for the future. The strategy has been clear and simple: pay down debt, keep costs under control and put some money away for a rainy day (or perhaps a pandemic).

The achievements for the season have included:

- Completion of the members' area renovation;
- Completion of the shed and storage facility at the new property;
 Poduction of not dobt by \$318,000
- Reduction of net debt by \$318,000 from a peak of \$981,000 to \$679,577 at the end of the season;
- Sale of the old Hilux patrol ute following purchase of the new Hilux king cab ute last year;
- Investment in a variety of patrol and surf sports equipment.

We have pushed hard in seeking grants for new equipment and clubhouse maintenance. We currently have active grant applications totalling \$50,000 which will provide funding towards the refurbishment and upgrade of the first aid room, replacing the roller doors in the gear room and upgrading the Club's website to add a range of member-focussed functionality.

Our operations are supported by three key sources of revenue: sponsorship, grants and fundraising, and the Supporters Club. Of total revenue for the year of \$1.63 million, the Supporters Club provided approximately 81%, our sponsors 6%, grants and fundraising of approximately 8%.

On the fundraising front, once again the golf day in March was a spectacular success in raising over \$10,000 for the Club – particular thanks to Paul Norman for countless hours invested in organising this event. This season's SOS appeal was one of our most successful yet – thanks to all the members who gave their time to raise nearly \$5,000.

The support we receive from our sponsors is more important than ever and we are very grateful. Looking to the future, we are reviewing how our sponsors work with us to make sure their partnership with the Club continues to add as much value as possible.

Costs of running the club were roughly in line with last year at \$1.42 million.

After costs, the Club achieved a modest surplus of \$205,472 which has essentially been utilised entirely for the reduction of debt.

As is always the case it is the things you don't see coming that cause the damage and you couldn't find a better testament to this than the new Corona virus – a sobering reminder of the importance of saving for a rainy day. Thankfully we went into the shutdown financially strong and were able to respond quickly. Unsurprisingly the Covid-19 drama has presented

challenges and without the benefit of a crystal ball we, like everyone else, have had to work it out as we go. We are well positioned to weather the storm and get going again hopefully sooner rather than later.

A huge thanks goes to our members, the Management Committee, the Supporters Club team and our sponsors for their support and resilience throughout the season.

General Information

The financial statements cover Coolum Beach Surf Life Saving Club Inc ("the club") as an individual entity.

Basis of Preparation

The financial statements are general purpose financial statements that have been prepared in accordance with Australian Accounting Standards – Reduced Disclosure Requirements of the Australian Accounting Standards Board and the *Australian Charities and Not-for-profits Commission Act 2012*. The club is a not-for-profit entity for financial report purposes under Australian Accounting Standards.

Australian Accounting Standards set out accounting policies that the AASB has concluded would result in financial statements containing relevant and reliable information about transactions, events and conditions. Material accounting policies adopted in the preparation of these financial statements are presented below and have been consistently applied unless otherwise stated.

The financial statements, except the cash flow information, have been prepared on accrual basis and are based on historical costs, modified where applicable, by the measurement at fair value of selected non-current assets, financial assets and financial liabilities. The amounts presented in the financial statements have been rounded to the nearest Australian dollar.

The financial statements were authorised for issue on 24 July 2020 by the Board of Management.

Comparative Figures

When required by Accounting Standards, comparative figures have been adjusted to confirm changes in presentation for the current financial year.

New Accounting Standards 2020

The adoption of AASB 15 Revenue from contracts with Customers, AASB 16 Leases and AASB 1058 Income for Not for Profits has not had a material impact on the Club for the 2020 financial year.

(a) Income Tax

The Australian Charities and Not-for-profit Commission have endorsed the association as a charitable institution.

No provision for income tax has been raised as the association is exempt from income tax under Section 50-5 of the *Income Tax Assessment Act 1997*.

(b) Cash and Cash Equivalents

Cash and cash equivalents include cash on hand, deposits held at call with banks, other short-term highly liquid investments with original maturities of three months or less, and bank overdrafts. Bank overdrafts are shown within short-term borrowings in current liabilities on the Statement of Financial Position.

(c) Property, Plant and Equipment

Property, plant and equipment are measured on the cost basis or fair value as indicated less where applicable, less depreciation and impairment losses.

Property, plant and equipment are measured on the cost basis and are therefore carried at cost less accumulated depreciation and any accumulated impairment losses. In the event the carrying amount of plant and equipment is greater than the estimated recoverable amount, the carrying amount is written down immediately to the estimated recoverable amount and impairment losses are recognised either in profit or loss or as a revaluation decrease if the impairment losses relate to a revalued asset. A formal assessment of recoverable amount is made when impairment indicators are present (refer to Note 1(f) for details of impairment).

Subsequent costs are included in the asset's carrying amount or recognised as a separate asset, as appropriate, only when it is probable that future economic benefits associated with the item will flow to the club and the cost of the item can be measured reliably. All other repairs and maintenance are recognised as expenses in profit or loss in the financial period in which they are incurred.

Plant and equipment that have been contributed at no cost or for nominal cost are recognised at the fair value of the asset at the date it is acquired.

Depreciation

The depreciable amount of all fixed assets including capitalised leased assets, is depreciated on a diminishing value basis over their estimated useful lives to the club commencing from the time the asset is held ready for use. Leasehold improvements are depreciated over the shorter of either the unexpired period of the lease or the estimated useful lives of the improvements.

The assets' residual values and useful lives are reviewed, and adjusted if appropriate, at each reporting date.

An asset's carrying amount is written down immediately to its recoverable amount if the asset's carrying amount is greater than its estimated recoverable amount.

Gains and losses on disposal are determined by comparing proceeds with the carrying amount. These gains or losses are included in the statement of profit and loss and other comprehensive income.

(d) Leases

Accounting Policy for Leases - 2020 Financial Year

For any new contracts entered into on or after 1 May 2019, the Club considers whether a contract is, or contains a lease. A lease is defined as 'a contract, or part of a contract, that conveys the right to use an asset (the underlying asset) for a period of time in exchange for consideration'.

To apply this definition the Club assesses whether the contract meets three key evaluations which are whether:

- the contract contains an identified asset, which is either explicitly identified in the contract or implicitly specified by being identified at the time the asset is made available to the Club;
- the Club has the right to obtain substantially all of the economic benefits from use of the identified asset throughout the period of use, considering its rights within the defined scope of the contract;
- the Club has the right to direct the use of the identified asset throughout the period of
 use. The Club assess whether it has the right to direct 'how and for what purpose'
 the asset is used throughout the period of use.

Measurement and recognition of leases as a lessee

At lease commencement date, the Club recognises a right-of-use asset and a lease liability on the balance sheet. The right-of-use asset is measured at cost, which is made up of the initial measurement of the lease liability, any initial direct costs incurred by the Club, an estimate of any costs to dismantle and remove the asset at the end of the lease, and any lease payments made in advance of the lease commencement date (net of any incentives received).

The Club depreciates the right-of-use assets on a straight-line basis from the lease commencement date to the earlier of the end of the useful life of the right-of-use asset or the end of the lease term. The Club also assesses the right-of-use asset for impairment when such indicators exist. At the commencement date, the Club measures the lease liability at the present value of the lease payments unpaid at that date, discounted using the interest rate implicit in the lease if that rate is readily available or the Club's incremental borrowing rate.

Lease payments included in the measurement of the lease liability are made up of fixed payments (including in substance fixed), variable payments based on an index or rate, amounts expected to be payable under a residual value guarantee and payments arising from options reasonably certain to be exercised.

Subsequent to initial measurement, the liability will be reduced for payments made and increased for interest. It is remeasured to reflect any reassessment or modification, or if there are changes in in-substance fixed payments. When the lease liability is remeasured, the corresponding adjustment is reflected in the right-of-use asset, or profit and loss if the right-of-use asset is already reduced to zero.

The Club has elected to account for short-term leases and leases of low-value assets using the practical expedients. Instead of recognising a right-of-use asset and lease liability, the payments in relation to these are recognised as an expense in profit or loss on a straight-line basis over the lease term. On the statement of financial position, right-of-use assets have been included in property, plant and equipment and lease liabilities have been included in trade and other payables.

The Club as a lessor

The Club's accounting policy under AASB 16 has not changed from the comparative period. As a lessor the Club classifies its leases as either operating or finance leases. A lease is classified as a finance lease if it transfers substantially all the risks and rewards incidental to ownership of the underlying asset, and classified as an operating lease if it does not.

Accounting Policy for Leases - 2019 Financial Year

Leases of property, plant and equipment, where substantially all the risks and benefits incidental to the ownership of the asset but not the legal ownership are transferred to the entity, are classified as finance leases.

Finance leases are capitalised, recognising an asset and a liability equal to the present value of the minimum lease payments, including any guaranteed residual values.

Leased assets are depreciated on a straight-line basis over their estimated useful lives where it is likely that the entity will obtain ownership of the asset. Lease payments are allocated between the reduction of the lease liability and the lease interest expense for the period.

Lease payments for operating leases, where substantially all the risks and benefits remain with the lessor, are recognised as expenses on a straight-line basis over the lease term

Lease incentives under operating leases are recognised as a liability and amortised on a straight-line basis over the life of the lease term.

(e) Financial Instruments

Initial recognition and measurement

Financial assets and financial liabilities are recognised when the entity becomes a party to the contractual provisions of the financial instrument, and are measured initially at fair value adjusted by transactions costs except for those carried at fair value through profit or loss, which are measured initially at fair value. Subsequent measurement of financial assets and financial liabilities are described below.

Financial assets are derecognised when the contractual rights to the cash flows from the financial asset expire, or when the financial asset and all substantial risks and rewards are transferred. A financial liability is derecognised when it is extinguished, discharged, cancelled or expires.

Classification and Subsequent Measurement of Financial Assets

Except for those trade receivables that do not contain a significant financing component and are measured at the transaction price, all financial assets are initially measured at fair value adjusted for transaction costs (where applicable).

For the purpose of subsequent measurement, financial assets other than those designated and effective as hedging instruments are classified into the following categories upon initial recognition:

- amortised cost
- fair value through profit or loss (FVPL)
- equity instruments at fair value through other comprehensive income (FVOCI)

All income and expenses relating to financial assets that are recognised in profit or loss are presented within finance costs, finance income or other financial items, except for impairment of trade receivables which is presented within other expenses.

Classifications are determined by both:

- The entities business model for managing the financial asset
- The contractual cash flow characteristics of the financial assets

All income and expenses relating to financial assets that are recognised in profit or loss are presented within finance costs, finance income or other financial items, except for impairment of trade receivables, which is presented within other expenses.

Financial assets at amortised cost

Financial assets are measured at amortised cost if the assets meet the following conditions (and are not designated as FVPL):

- They are held within a business model whose objective is to hold the financial assets and collect its contractual cash flows.
- The contractual terms of the financial assets give rise to cash flows that are solely payments of principal and interest on the principal amount outstanding.

After initial recognition, these are measured at amortised cost using the effective interest method. Discounting is omitted where the effect of discounting is immaterial.

Financial assets at amortised cost (continued)

The club's cash and cash equivalents, trade and most other receivables fall into this category of financial instruments as well as long-term deposit that were previously classified as held-to-maturity under AASB 139.

Financial assets at fair value through profit or loss (FVPL)

Financial assets that are held within a different business model other than 'hold to collect' or 'hold to collect and sell' are categorised at fair value through profit and loss. Further, irrespective of business model financial assets whose contractual cash flows are not solely payments of principal and interest are accounted for at FVPL. All derivative financial instruments fall into this category, except for those designated and effective as hedging instruments, for which the hedge accounting requirements apply (see below).

Equity instruments at fair value through other comprehensive income (Equity FVOCI)

Investments in equity instruments that are not held for trading are eligible for an irrevocable election at inception to be measured at FVOCI. Under Equity FVOCI, subsequent movements in fair value are recognised in other comprehensive income and are never reclassified to profit or loss. Dividends from these investments continue to be recorded as other income within the profit or loss unless the dividend clearly represents return of capital. This category includes unlisted equity securities that were previously classified as 'available-for-sale' under AASB 139.

Impairment of Financial assets

AASB 9's impairment requirements use more forward looking information to recognize expected credit losses - the 'expected credit losses (ECL) model'. Instruments within the scope of the new requirements included loans and other debt-type financial assets measured at amortised cost and FVOCI, trade receivables and loan commitments and some financial guarantee contracts (for the issuer) that are not measured at fair value through profit or loss.

Trade and other receivables

Trade and other receivables include amounts due from customers for goods sold and services performed in the ordinary course of business. Receivables expected to be collected within 12 months of the end of the reporting period are classified as current assets. All other receivables are classified as non-current assets.

Trade and other receivables are initially recognised at fair value and subsequently measured at amortised cost using the effective interest method, less any provision for impairment. Refer to Note 1(f) for further discussion on the determination of impairment losses.

Classification and measurement of financial liabilities

The club's financial liabilities include borrowings and trade and other payables. Financial liabilities are initially measured at fair value, and, where applicable, adjusted for transaction costs unless the club's designated a financial liability at fair value through profit or loss.

Subsequently, financial liabilities are measured at amortised cost using the effective interest method except for derivatives and financial liabilities designated at FVPL, which are carried subsequently at fair value with gains or losses recognised in profit or loss (other than derivative financial instruments that are designated and effective as hedging instruments).

Impairment

Derecognition

Financial assets are derecognised where the contractual rights to receipt of cash flows expires or the asset is transferred to another party whereby the entity is no longer have any significant continuing involvement in the risks and benefits associated with the asset. Financial liabilities are derecognised where the related obligations are either discharged, cancelled or expire. The difference between the carrying value of the financial liability extinguished or transferred to another party and the fair value of consideration paid, including the transfer of non-cash assets or liabilities assumed is recognised in the profit or loss

(f) Impairment of Assets

At each reporting date, the club reviews the carrying values of its tangible and intangible assets to determine whether there is any indication that those assets have been impaired. If such an indication exists, the recoverable amount of the asset, being the higher of the asset's fair value less cost to sell and value in use, is compared to the asset's carrying value. Any excess of the assets carrying value over its recoverable amount is expensed to the statement of comprehensive income.

Where it is not possible to estimate the recoverable amount of an individual asset, the club estimates the recoverable amount of the cash-generating unit to which the asset belongs.

(g) Employee Provisions

Provision is made for the club's liability for employee benefits arising from services rendered by employees to the end of the reporting period. Employee benefits that are expected to be settled within one year have been measured at the amounts expected to be paid when the liability is settled. Employee benefits payable later than one year have been measured at the present value of the estimated future cash outflows to be made for those benefits.

In determining the liability, consideration is given to employee wage increases and the probability that the employee may not satisfy vesting requirements. Those cash outflows are discounted using market yields on corporate bonds with terms to maturity that match the expected timing of cash flows attributable to employee benefits. Contributions are made by the club to employee superannuation funds and are charged as expenses when incurred.

(h) Provisions

Provisions are recognised when the club has a legal or constructive obligation, as a result of past events, for which it is probable that an outflow of economic benefits will result and that outflow can be reliably measured. Provisions recognised represent the best estimate of the amounts required to settle the obligation at the end of the reporting period.

(i) Revenue

Non-reciprocal grant revenue is recognised in profit or loss when the club obtains control of the grant, it is probable that the economic benefits gained from the grant will flow to the club and the amount of the grant can be measured reliably.

If conditions are attached to the grant which must be satisfied before it is eligible to receive the contribution, the recognition of the grant as revenue will be deferred until those conditions are satisfied.

When grant revenue is received whereby the club incurs an obligation to deliver economic value directly back to the contributor, this is considered a reciprocal transaction and the grant revenue is recognised in the statement of financial position as a liability until the service has been delivered to the contributor, otherwise the grant is recognised as income on receipt.

The club received non-reciprocal subsidies from the government. The subsidies are recognised as income on receipt.

Revenue from sale of goods comprises revenue earned from sale of goods donated and resale. Sales revenue is recognised when the control of goods passes to the customer.

Rental income is accounted for on a straight line basis over the lease term.

Donations collected, including cash and goods for resale, are recognised as revenue when the group gains control, economic benefits are probable and the amount of the donation can be measured reliably.

Interest revenue is recognised on a proportional basis taking into account the interest

rates applicable to the financial assets.

All revenue is stated net of the amount of goods and services tax (GST) where applicable.

(j) Goods and Services Tax (GST)

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Taxation Office. In these circumstances, the GST is recognised as part of the cost of acquisition of the asset or as part of the expense.

Receivables and payables are stated inclusive of the amount of GST receivable or payable. The net amount of GST recoverable from, or payable to, the ATO is included with other receivables or payables in the statement of financial position.

Cash flows are presented on a gross basis. The GST components of cash flows arising from investing or financing activities, which are recoverable from or payable to the ATO, are presented as operating cash flows included in receipts from customers or payments to suppliers.

(k) Trade and Other Receivables

Accounts receivable and other debtors include amounts due from members as well as amounts receivable from customers for goods sold in the ordinary course of business. Receivables expected to be collected within 12 months of the end of the reporting period are classified as current assets. All other receivables are classified as non-current assets.

Accounts receivable are initially recognised at fair value and subsequently measured at amortised cost using the effective interest rate method.

(I) Inventories

Inventories are measured at the lower of cost and net realisable value. Net realisable value is the estimated selling price in the ordinary course of business, less the estimated costs of completion and selling expenses.

(m) Trade and Other Payables

Accounts payable and other payables represent the liability outstanding at the end of the reporting period for goods and services received by the club during the reporting period which remain unpaid. The balance is recognised as a current liability with the amounts normally paid within 30 days of recognition of the liability.

(n) Critical Accounting Estimates and Judgements

The Board of Management evaluate estimates and judgements incorporated into the financial statements based on historical knowledge and best available current information. Estimates assume a reasonable expectation of future events and are based on current trends and economic data, obtained both externally and within the club.

Key Estimates - Impairment

The Board of Management assess impairment at each reporting date by evaluating conditions specific to the club that may lead to the impairment of assets. Where an impairment trigger exists, the recoverable amount of the asset is determined. Value-inuse calculations performed in assessing recoverable amounts incorporate a number of key estimates. No impairment has been recognised in respect of the current year.

(o) Fair Value of Assets and Liabilities

The club measures some of its assets and liabilities at fair value on either a recurring or nonrecurring basis, depending on the requirements of the applicable Accounting Standard

Fair value is the price the club would receive to sell an asset or would have to pay to transfer a liability in an orderly (i.e. unforced) transaction between independent, knowledgeable and willing market participants at the measurement date.

As fair value is a market-based measure, the closest equivalent observable market pricing information is used to determine fair value. Adjustments to market values may be made having regard to the characteristics of the specific asset or liability. The fair values of assets and liabilities that are not traded in an active market are determined using one or more valuation techniques. These valuation techniques maximise, to the extent possible, the use of observable market data.

(q) Economic Dependence

The Club is dependent upon the ongoing receipt of donations and rental income from Coolum Beach Surf Life Saving Supporters Inc. to ensure the ongoing continuance of its operations. At the date of this report, the Board of Management has no reason to believe that this financial support will not continue.



General Manager Report



"Hello to all the fantastic Coolum SLSC Members, it's been a very busy year for your Supporters Club, up until COVID-19 hit our shores and then everything changed."

We sadly closed our doors on Monday the 23rd of March following the direction of the Federal Government in what was the most turbulent week in the Hospitality Industries history. On the prior Wednesday the 18th of March the Government introduced strict Social Distancing rules which cut the number of customers we could have by around 40%, two days later on Friday the 20th of March the Government made the social distancing rules even harsher which meant that we could have less than 60% of the number of customers than we could normally have and then two days later on Sunday the 22nd of March the Government decided to shut us down the following day. The changes that were required to meet the social distancing rules were extreme and resulted in a drop of around 60% of our income so in many wavs I was relieved that the government decided to close us as it would have resulted in death by a thousand cuts for the Supporter's Club and its staff as everything was more than halved.

Since we have been closed we have worked very hard to keep our staff informed and supported. So that you are aware, we have been looking after our staff the best way we can during this shutdown period. For the first month of the shutdown, we continued to pay ALL staff including casuals who have been with us for more than a year. This gave our staff enough time to either obtain government support and or another job to help them out during these tough times. Thankfully the federal government introduced the JobKeeper subsidy that many of our employees qualified for which kicked in from the 30th of March. To assist our staff with their mental

health during these sad times we have an Employment Assistance Program in place for all our staff which gives each staff member and a member of their family access to 6 counseling sessions per year. These sessions remain confidential and will become a lifeline for our team if they are mentally or emotionally struggling during this time.

Thanks to the JobKeeper program we were able to reopen for takeaway and home delivery on the 29th of April.

This diversification strategy will most likely become a permanent fixture of our business moving forward in these uncertain times.

As I write this report we are at the beginning of the shut down as previously mentioned. Our country along with others around the world is at an almost complete standstill while COVID-19 filters through the community. It gives us a chance to reset and focus on what's important to our business, our customers and staff. We don't know when we will be able to fully reopen but are told that it may not be until September or October 2020. Should we be faced with similar social distancing rules that were thrust upon us in late March then it would be a very difficult landscape to operate under and completely change the face of our business. Even if there are no social distancina requirements we are most likely going to be operating in a post-war like era which means that we have to change our offer to suit whatever economy and society we are faced with. You can rest assured that whatever needs to be done, whatever tough decisions have to be made, it will happen as the Supporters Club is here to

ensure that we support Coolum Beach Surf Lifesaving Club financially and operationally.

At the beginning of April and our shutdown period we embarked on an ambitious target of 10,000 new and renewed social memberships during our forced shutdown period. This initiative has started very well and thanks to the generous nature of our social members the SLSC has received over \$3000 in donations in three weeks along with hundreds of new and renewed memberships.

Business for the first 10 months of the financial year was great! Financially we were tracking for our best season on record but with the loss of nearly 6 weeks in trade it has resulted in our second best result behind last financial year. We still managed to beat the 2017/18 season in turnover (TBC with financials) which is still an exceptional result.

Our Bar has continued excellent growth. In December we partnered back up with Lion Nathan (XXXX) brewery for 63% of our taps leaving us 37% to do what we want with. This has worked quite well and helped us continue our great growth. We have reinvested in our bar by putting a new improved beer system in that enables us to have all 16 of our draught products at each bar which enables customers to see all our products in one place no matter which bar they go to and also saves our staff from having to move around the bar to get access to all the beers that we have on tap. We were also able to tidy our cellar up and make it much more efficient. We also partnered with Asahi beverages who

supply Schweppes soft drinks for our bulk postmix soft drink supply. This move has dramatically improved our profit margins for soft drink sales. My thanks to Tyson, Petra, Toby, Danni and all the Bar team for their great work.

Our restaurant has had another solid year. My thanks to Kirstin, Isis Denver, Chef Tim, Andy and their respective teams for continuing to produce a great experience for the many thousands of members and visitors that come through our door every week.

Our membership has grown beyond 15,000 which is a testament to our great Supporters Club and what it means to the community.

I would like to thank all of our Team here at Coolum Surf Club and praise them for their hard work, dedication and loyalty shown to me and our Club. They all do a great job and this is reflected by the clubs' continual performance.

We restructured our middle management this year with the promotion of Sharon Sutton from Admin and Finance Manager to the Assistant General Manager. Sharon has served the club flawlessly for over 10 years and has stepped up to the plate to help the club go to the next level in all facets of the Club's operation and financial structure. Sharon has been doing a fantastic job and the structure of the team is looking good for when we can get back to normal trading conditions. Thanks Sharon.

My thanks to President John Ellingsen, Treasurer Garry Green, Secretary Peter Howard and all of the Supporters Committee. These gents consistently give me their full support and autonomy to run the club and make some fantastic decisions on the financial direction and governance of the club.

We have been pushing forward with becoming a greener club and created a green statement throughout the year. As a club and as a responsible corporate entity of our world we have been working hard to reduce our carbon footprint and become more environmentally friendly by implementing a number of measures, which includes the following:

- Installing a 100kW Solar System in February last year that has generated enough energy to offset more than 66 Tonnes of carbon emissions which equates to the planting of 220 trees.
- Installing a PulpMaster food waste management system. This transforms food waste into recyclable pulp that is used to produce organic fertilizer. During normal club operations we are pulping in excess of 3 tonnes of food waste every week. That equates to more than 150 tonnes every year saved from landfill.
- We take our responsibility to our waterways seriously and to help reduce our chemical footprint we have switched to the eWater system. This has replaced 50% of our current cleaning chemicals with eWater cleaner and sanitizer products. As eWater is a standalone system, we also have reduced chemical packaging in the process as it is 'made' on site.
- We have switched to biodegradable straws.
- By crushing all our glass via the BottleCycler we reduce the amount of bin volume. Reduced volume = fewer and smaller trucks = less fuel = less CO2 pollution = less collection noise.
- We recycle all our plastics and cardboard, and our Newspapers are donated to a local company that makes eco-friendly packaging.
- We utilise biodegradable and compostable packaging.
- We supply bio cups for all coffee

- purchases.
- We replaced polystyrene take away containers with environmentally friendly cardboard.
 We replaced plastic sauce cups and spoons with paper sauce cups and biodegradable spoons.
- We moved to LED lighting and microwave sensor lighting which is 80% more energy-efficient than fluorescent or incandescent lights. 95% of the energy in LEDs is converted into light and only 5% is wasted as heat. Less energy use reduces the demand from power plants and decreases greenhouse gas emissions.
- We use local suppliers where possible to provide fresh and locally sourced ingredients available to us to reduce the amount of transport required to deliver these items and to ensure freshness and to support local business on the Sunshine Coast, throughout Queensland and Australia.

Some of the above-mentioned initiatives have also proven to be cost-saving measures that allow us to provide better financial support to our Surf Life Saving Club as well as local Not-For-Profit charitable groups.

In May 2020 the Supporters Club won Best Surf Lifesaving Supporters Club in Queensland at the Clubs Queensland Awards for Excellence. Along with this win we were finalist in 3 other categories. We came 3rd in Queensland for Best Dining, 2nd for Education and 3rd for being the Heart of the Community.

Thanks to all active members who patronise the Supporters Club. Cheers and I look forward to seeing you all upstairs.

CENTENARY SEASON LAUNCH

There was one moment, captured concisely in two telling words at the official Easter Saturday launch of Coolum Beach Surf Life Saving Club's historic Centenary Celebrations, on a windy afternoon with past and present members and dignitaries crowding the members' terrace, that said all that had to be said.

Life Member Keith Peterie, 87, one vital half of the "heart and soul" of the surf club, turned to a fellow serving Life Member seated beside him and said: "Good job".

Beside Keith was his lifesaving brother in arms, Ron Want, still sharp of mind and straight of stature as he and Keith later posed with Coolum Beach SLSC acting Club Captain Mick Sell dressed in the club's traditional red, white and sky-blue competition cap.

Overhead, as threatening rain clouds scudded in the 25km wind gusts, causing quite a flap in the club's proud Centenary Flag. This had just been raised for the first time as the club's symbol of strength and unity, made unbreakable over 10 decades of community service.

On the beach a traditional "old school" patrol arena with tower and clubbie dressed in Speedos in a homage to the 1960s and 70s. He was the embodiment of Vigilance and Service, eyes always out to sea.

Shortly after 3pm, this pivotal nod to all that had gone before and all the greatness yet to come, began with traditional custodian Lyndon Davies, a proud Gubbi Gubbi man, and his didgeridoo performing the Welcome to Country.

Watching on with huge relief, as more than 15 months of planning, that could not be dampened by a brief rain squall which sent the mass of Centenary Launch guests scurrying inside for 10 minutes until the all-clear was sounded, was Centenary Committee chair Kate Stockley. Kate and her committee of (Kate's father and Life Member) Ian Norman, Paul Norman, club historian and Life Member Peter Gardiner, Greg Bott, Emma Rahui and Trudy Pieters, had planned meticulously to give this occasion the very special stamp it deserved.

A proud 2018/19 Club President Fred Stokes had no doubt that this club had stood the test of time (but only just on one very dark drowning tragedy) as he welcomed one and all. He said this club was built on the spirit of volunteers wanting to do something for someone else, "community-minded people with hearts as big as Phar Lap" who "put their lives on the line to save someone else, and I'm very proud to be in your company". Then local State MP for Ninderry, Dan Purdie, a former policeman who knew all about putting your life on the line for others in times of emergency, paid tribute to the lifesavers' effort. "What makes Coolum special is that community culture that we have here and central to community and culture, is and always has been the last 100 years, the Coolum Surf Life Saving Club." "When you break it all down - lifesaving is about donating your time to look after those people at the beach in the water. The Coolum surf club has set that tone for the wider community."



Patrol 5 Patrol Captain (PC) Peter Gardiner then stepped up to launch the update of the Club's official history book he'd completed in a hectic 18 months, along with the words for the special coffee table pictorial companion to mark the century. The narration of this was told with writer's licence in the first person by club founder, the late and always great, Jack Morgan. Peter said the early patrol pioneers like Jack Morgan, Spencer Browne, Ernie Berg and George Warren passed on their

skills and dedication to the likes of Keith Peterie and Ron Want "whose baptism of fire as young clubbies was the 1948 Boxing Day drownings, when war hero Dick Lugge was dragged under while attempting the bravest of belt rescues in a truly monstrous surf". "None of us will ever be able to pay back the debt we owe Keith and Ron in early 1949, for not walking away from this club when they were the last two members standing. They were the club's lifeline when we needed it the most and they came through by recruiting and training up a bunch of young kids to carry on the Coolum Beach SLSC legacy."

Life Member John Ellingsen, a very colourful club lynchpin among many, then had the privilege to interview Ron and Keith, as they relived, anecdotally, their famous walk up the beach to decide whether to leave the club, which would have closed its doors.

Their watershed decision is now the stuff of local legend and a powerful backmarker to a club defined, after 100 years of outstanding volunteer dedication.



PRESENTATION NIGHT

The Coolum Beach's May 25, Centenary Celebrations Annual Presentation Dinner at a Coolum State School hall decked out with nostalgia was a barometer for good things to come for the next 100 years.

Outgoing president Fred Stokes spoke of the club's pride in reverting back to the historical club colours for its competition cap and of the Coolum Beach SLSC March Past Team making a comeback at the Australian Championships. "With our very own centenary merchandise, the launch of our club history books and our very own Centenary Ale, we certainly have a lot to be excited about," Fred said.

"We have seem many different

clubhouses as part of the building evolution to what we have today. We've are very fortunate to be in a position to purchase a second property on the outskirts of town and we've almost finished construction of a rather large storage shed. "All these material things are of course appreciated and make life comfortable, but the club wouldn't be the place that it is today, or as successful, if wasn't for the 100 years of grit and determination, camaraderie and mateship and the unwavering commitment to attempt to perform basic lifesaving services throughout the year to keep Coolum Beach safe," Fred said.

And it was one of last official duties to unveil the Centenary art work donated by club member and accomplished artist John Pearson to be displayed in the club room, a forerunner to the commissioned public art piece by Coolum artist Blair McNamara, who was one of the club's early nippers.

Acting club captain Mick Sell recapping on the previous season spoke of the club's commitment throughout some tough conditions, including being hit by the still powerful forces of Cyclone Omar.

Mick thanked all the rescue crews in the IRBs, on boards and with tubes, and all those who stood watch on the water including the tower radio operators "who have such an important role to play in keeping the beaches safe". He said these eagle-eyed radio volunteers reported changes in the beach conditions and reported them to the patrol PCs. Di McFarlane and Bruce Mouland won the Frank Wood Memorial Trophy for Best Radio Operator.

"I'd also like to thank Chief training Officer Gail (King) and the TAF (trainers, assessors and facilitators) this year for their hard work this year and the trainers for helping run our bronze squads and keeping members proficient." He thanked the Management Committee, the admin officers, the nippers crew and all these combined efforts "make us the successful club we are today".

Eighteen-year veteran Gail, who was bowing out from her influential role in the club, paid tribute "the effort, commitment and personal time that these awesome members put into making the Coolum Beach Training Team". There were 107 new training awards achieved, an amazing 44 new bronze members and 13 new SRCs, the juniors who are the lifeblood of the club. She paid tribute to the efforts of all, including Chris Smithies and Ernie Burrows for going above and beyond and to Shane Urban for being named Instructor of the Year.

All the PCs were brought on to the stage first up to receive special presentations for their invaluable guiding hands, while the awards kept coming thick and fast such as Champion Patrol to Patrol 5. That season the PCs oversaw a remarkable 12,011 patrol hours, with 7,374 preventative actions for zero lives lost. Colm O'Reilly and Kaitlin Webster shared the Most Promising New Member Award, while Logan Pieters logged an amazing 150 hours plus for the season to take out Outstanding Patrol Service. Not far behind in their dedication to the red and yellow duties were young gun Ben Campbell, Shane Urban and Janina Cook who completed more than 100

But the stand-out possibly was former lifeguard Bruce Dunne who has discovered the elixir of youth when it comes to board riding to take out his fifth straight Australian Longboard Champion plus picking up gold in the Short Board in tough conditions at Broadbeach on the Gold Coast.

Very few members can match Ben Campbell for his dedication to patrols, including Wave Runner extra duties and IRB racing and his role as club IRB officer. He's among the new wave of emerging young leaders in the club, so it was fitting he was awarded the Dick Lugge Best Patrol Member.

Surf sports coach Chris Atkinson has been one of the club's best contributors to its reborn competitive "muscle" in recent years and Sting Zillman would have been proud to have the trophy named in his honour presented to Chris. Veteran PC and club historian Peter Gardiner took out the David Cush Meritorious Award for his efforts to help preserve and enhance the club's amazing culture of public service.





AGM

A well-attended club AGM this year saw outgoing Treasurer of nine years and incoming President, Ian Norman succinctly sum up the net worth of the bricks and mortar that continues to pay an incalculable dividend to help retain its all-important human capital. "In our Centenary season, it is great to be able to report the club remains in a strong financial position.

After three years as Club President Fred Stokes stood down. President elect lan





Peter Lambert



In June this year Coolum Beach lost one of its important living links to its rich history with the passing of the Life Member Peter Lambert who was still active in his early 90s.

This bear of a man who in his competitive days was a strong belt swimmer, loved nothing better than a body surf out the back with his fellow 79ers, The Coolum Beach SLSC blog reported: "It is with much sadness that Coolum Beach Surf Lifesaving advises of the passing of Life Member Peter Lambert on 28 May 2019. Peter was a highly regarded architect who designed the iconic 1962 "shark tower" Coolum Beach clubhouse which became a much-loved Sunshine Coast landmark until it was replaced in 1985. Retiring to Coolum Terrace in the 1980s Peter was a foundation member of the famous 79ers early morning swimmers along with Cole King and Ron Hooper."

Despite the chilly conditions on June 22, the 79ers swam out to honour Peter as his ashes were spread in the water he loved so much.

Back to Coolum in our Centenary Year

This was a club room full to the brim with more than 70 years of lifesaving talent, who between them have saved dozens, if not hundreds, of lives of Coolum Beach swimmers.

Coolum Beach Surf Life Saving Club's Centenary Back to Coolum gathering of past and present lifesaving talent on that October Saturday afternoon will long be remembered as the most successful of "clubbie" reunions to date, setting the benchmark for many more to come.

Fittingly the club's patrons, this special triumvirate of Ron Want, Keith Peterie and a still very active patrol captain in Dave Cush, were among those celebrating with plenty of lively yarns, which grow more colourful with the years. Ron and Keith, now in their late 80s, between them had together saved the club from almost folding in 1949, to now see it thriving with more than 80 honoured guests enjoying the hospitality of the newly updated members' common room.

As this annual reunion, created by Dave to link the club's rich living past with its present-day membership, was reliving memories of the famous post patrol "keg in the shed" bonding sessions, down on the Gold Coast modern day club members were earning podium finishes in the masters and junior sections of Coolangatta Gold endurance event. While 400m away on the southern stretch of beach, Patrol Captain Wayne Porter and his troops were keeping a 100-year tradition of no lives lost between the flags well and truly alive.

Just the week before more than 80 volunteers had been on duty over the three-day Queen's Birthday weekend looking after bumper end of school holiday crowds without missing a beat.

Club president Ian Norman is one of the club's golden oldie lucky Patrol 13 team headed by "Cushie", touted as the oldest living patrol team in Australian lifesaving. Ian is a relative "pup" of this team, having joined the club as a junior in 1974 and since then has been basically keeping on, keeping on with his patrol duties and active competition.

It was lan's "privilege" to welcome the 100-year gathering before heading down to the Gold Coast for Coolum's ongoing assault on the Coolangatta Gold on Sunday. He messaged after the Gold wrapped up: "Well done to the long course teams today. Five teams in total – two bronze medals and some great racing."

The marvellous reality for a surf club celebrating 100 years of volunteer service between the flags, is that the club is undergoing an increasingly strong resurgence of surf sports competitors, led by its veteran and masters ranks who are inspiring a fresh wave of juniors.

Among the surf club's many special quests this day is the daughter of one of Coolum Beach SLSC's supreme beach sprinters and most faithful servants, the late and great Alan Casey. Leanne was sharing her memories of her many good times at the club with the likes of Keith and Ron, who are both still sharp of mind. As well, former clubbie Liam Daly, son of former Life Member the late John Daly, and brother to local lifeguard and Life Member Michael, had made the trek from the Northern Territory where he serves Australia's Customs and Border Security Service.

Other welcome returns were from Life Member Michael Gibson now of Hervey Bay and Max Bartho, who joined the likes of Back to Coolum stalwarts Lou Hesse, Life Members George Sakrzewski, Warren 'Mopey' Gifford and Ian Swan for an afternoon of banter.

This special occasion was marked by the official unveiling of its historic 100-year celebration mural created by former club nipper and local worldrenowned artist Blair McNamara. Blair's dad, Bill, a former Metropolitan Caloundra lifesaver who moved his



family to Coolum Beach in the early 1960s to enjoy the bigger surf break, passed away only recently aged 92. Bill drove the move to establish the first local Nippers called the Coolum Darts, back in the late 1960s, and Blair's artistic flair has long centred around preserving Coolum Beach's beach culture. So the Nipper, turned hardcore surfboard rider, was a perfect fit for this artistic celebration, focusing on the club's strong characters in juxtaposition around its famous 1960s clubhouse designed by recently deceased Life Member Peter Lambert.

President lan said in his welcome: "It's fantastic to see so many current and past members here, and a particular welcome to our life members. "It's been a great year, this season has been coming for a long time, 100 years obviously, but we've been planning this for three to four years." Ian said some of the highlights of the Centenary year including the club returning to compete in its traditional club cap colours of sky blue, red and white and re-establishing a march past team that competed at the Australian titles.

The Back to Coolum Day was the last formal celebration of the Centenary, which kicked off in April with the Centenary Celebration launch, followed by the Centenary awards dinner in May and then a community beach day in August embraced by hundreds of well-wishers. "The feedback from the public was very positive," Ian said. "It's been a great privilege to be President of the club for Centenary season. "The club is in good shape, upstairs continues to trade well under the stewardship of (Supporters Club President and Life Member) John Ellingsen.

Ian said the club's operation today with a multi-million turnover, was a far cry from the days when he and other members had to sell meat tray raffles at the Regatta Hotel in Brisbane

and Marcoola's Surf Air. He said the club employs about 70 people and has about 14,000 social members. "It puts down close to a million dollars a year (to the active club) to keep us running." lan said. One of the club's biggest assets is its 2.5 hectare parcel of land on Coolum Yandina Rd bought recently to help free up valuable space at the clubhouse. "We've got good patrolling gear, we've got a new (rescue) ute, a brand new side-by-side (patrol) vehicle, we're about to buy a new bus and we've got new IRBs. This club is what it is because of the people standing here in this room and the people who have come before us. We are proudly a volunteer organisation. Every (patrol season) weekend some 70 or 80 people stand on that beach to patrol the beach. The level of commitment that we get from our current and past members is astonishing. I thank everybody in this room for what you've done for the club. It is what it is because of what you've done. Here's to the next 100 years of Coolum Beach Surf Club. It's been a fantastic year that I'll never forget, so thank you very much Centenary (Organising) Committee."

Centenary Committee chair Kate Stockley has the final word: "What a journey it has been to get to the end of our Centenary Celebrations. I have heard nothing but positive feedback on everything that we have delivered."

meet a few people who I wouldn't have otherwise met and naturally I run into them at every carnival now. I'm in Greg Bott's patrol group 8. To be honest I've never had a patrol that has been too eventful – probably a product of good preventative work. The standard stuff, kids that fall over in knee deep water and panic, but that's about it."

Queensland is the best patrolled beach in the state. CBSLC president and Life member Ian Norman who has been actively involved with keeping the beach safe for almost half of its hundred years plus of "vigilance and service", believes this first-time accolade is the perfect follow up to the club's outstanding Centenary Celebrations.

lan's reaction: "What a great start to our new century. To be named Queensland's Number 1 beach by SLSQ is a fantastic feather in our cap. Although, I suspect most of our members would say that this is just making official what we already know." "We have been driving a strategic direction for many years now that has at its core 'to be the safest and friendliest beach' and it is great to see that this has been effective and has been recognised."

"Throughout our long and proud history we have never aspired to be the biggest club or the strongest competition club we have always aspired to be the best at what we do which is keeping the beach safe." "Our members take a lot of pride in being able to handle any surf conditions with Coolum Beach being recognised as one of the best places to go if you want a wave. This season also saw Coolum Beach become one of the wheelchair accessible beaches with our volunteer members diligently putting down the blue matting at the start of each patrol day." "It has been great for our members to do their bit in making someone's life just that little bit better. Every member, past member and supporter of the Coolum Beach lifesaving club should justifiably feel proud of this accolade," lan said.

Released to coincide with the end of

summer, the annual list of Queensland's top 10 patrolled beaches ranks popular locations based on safety, facilities and nearby services. Alma Bay (Magnetic Island) and Burleigh Heads on the Gold Coast make up the top three with SLSQ Sunshine Coast lifesaving co- ordinator Caige Price summing up Coolum's winning edge ... patrols that are on the ball. "Safety is our core focus as we aim for zero preventable deaths in Queensland public waters," Mr Price

Coolum Beach lifesavers watched over more than 270,000 beachgoers during summer, with surf lifesavers and lifeguards performing 30 rescues, 2275 first aid treatments and carrying out more than 8000 preventive actions. "When determining our top beaches, we consider patrol times and services, incident history, coastal conditions and the quality of visitor information on display," he said.

Coolum is patrolled 365 days a year by dedicated volunteer surf lifesavers and lifeguards, Mr Price said, with a second set of flags located at Coolum North providing beachgoers two safe swimming areas in proximity. "We also look at other factors such as how user-friendly the beach is, which includes considerations such as amenities, its location, access to parking and public transport, nearby services and cleanliness."

Across all of Queensland this summer, more than 1700 rescues were performed by surf lifesavers and lifesavers, a decrease of 33 per cent compared to the 2018/19 summer period. "It is a timely reminder to always consider your safety and swim between the red and yellow flags, no matter which beach

you choose to visit," Mr Price said. "The flagged areas not only represent the safest conditions on that particular beach but are also patrolled by qualified surf lifesavers and lifeguards."

Certainly, the above and beyond efforts our club goes to ensure Coolum beachgoers love coming back here has not gone unnoticed judging by our Facebook posts. Kim Gourlay: "Wow that's great, congrats to all involved. "Scotty Taylor: "Love where you, live great work guys."And Greg Whiteley summed up the club feelings: "Fantastic effort to all involved. We are a great club and we now have the best beach as well "

DOING OUR BIT FOR THE ENVIRONMENT AND THE COMMUNITY

Imagine 150 trees sprouting from the roof of Coolum Beach Surf Life Saving Club, sucking in tonnes of Co2 and pumping out oxygen over the beach. No, the surf club management committee in their wisdom has not decided to channel their inner earth child ... but had the foresight to install banks of solar panels on the clubhouse rooftop.

The club upstairs hospitality operation is also vitally aware of the need to look after the environment and has set about actively reducing its carbon footprint, which has led to cost savings to be distributed down the line. A few of the things they are doing include;

- the use of renewable energy through 100 Kw solar system removing 100 tonnes of Co2 from the atmosphere, or the equivalent of planting 150 trees each year.
- plastics have been removed along with styrofoam wherever possible in favour of biodegradable products.
- pulping four tonnes of food waste every week and converting it to ecofriendly fertiliser and recycling all the glass through its Bottle-Recycler system.
- using eWater (water quality and quantity modelling) to reduce the clubhouse chemical footprint by 50% and uses recycled rainwater before town supply.
- buying locally wherever possible to support the local growers and suppliers.

And now that free energy from the sun and green benefits is paying back big

dividends, not only to its members and the environment but is helping the club give back to its active lifesavers and appreciative community groups.

Our Supporters club set up its community benefit fund in 2010 to make donations to not-for-profit charitable entities both financially and in kind. Since then local groups to be given valuable support include; St Vincent de Paul, Meals on Wheels, Coolum and North Shore Coast Care, Quota and Lions Clubs of Coolum. In the past 12 months much-needed funds have been donated

to the Townsville flood victims, Coolum Rural firefighters and the CWA to help drought affected farmers.

If you think all this charity begins at our home club sounds like a fine sentiment, our Coolum Beach volunteer lifesavers raised \$400 through raffles at the annual patrol Christmas party and donated to 'Buy A Bale', a fundraiser making a difference to Australian farming families and Rural Aid as the crippling drought dug deeper into the famous bush "resolve". As has been duly noted on our club's Facebook: "The hay drive started back in September 2014 and has delivered over 160,000 bales of hay across four states and the money donated by our members will help contribute to another 20 bales of hay feeling proud.

None of the club's members' contribution to preserving life on the beach has been lost by Gold Sponsor Ken Mills Toyota, who also have a long history of community support where it counts.

YOUNG GUNS DOING US PROUD

Nothing measures the vitality of the club than its next generation and our finest young members have earned the club some positive press in the Sunshine Coast Daily. Thirteen nippers from a small sunshine coast surf club will take on Queensland's best at the upcoming Queensland Youth Surf Life Saving Championships.

Coolum Beach Nippers was excited to have so many of our best nippers qualify for state titles at the Branch Championships on February 8 and 9 and will now compete for the title of Queensland's best club in March.

Coolum Surf Club junior activities chairman and coach Mick Nagle said it was great to see so many kids qualify. "We had 23 go to branch and 13 who qualified, so that was a pretty good number and we will have a couple more nominate, so we will probably have a team of 18 compete," he said.

"It's awesome, it shows the other kids that they can be a part of the team and putting in the training and want to commit to join that team and go to the state titles and compete with all the clubs from North Queensland and the Gold Coast."

Mick joined the club nine years ago and said it was amazing to see it excel in the water side of Surf Lifesaving. "When I turned up, we were a beach (events) club and we have developed and pushed in the water, and now we've had the under 11 boys qualify for the swim team, which I believe is the first time," he said. "We have some strong individuals coming through and the team is really good."

Coolum Beach Surf Club under-11 athlete Brisa Canina qualified for the 1km run, the iron and board races and said she had some unfinished business. "I'm most excited for board. I want to beat the girls that beat me in the board final, which I came fourth in."

Under-11 1km runner Kaia Francey said she hoped to place within the state's top 10 but was just looking forward to the experience."I love hanging around all my friends and having fun," she said. "So, I'm looking forward to going down and having some fun."

Mick said it was great to see the girls qualify for their first state titles. "This is Brisa's second season in nippers, so she has come along really well especially in board. "And Kaia has done nippers for a couple years and she has just taken off in the water this season and it's been good to watch them both develop."

The Queensland Youth Surf Life Saving Championships are being held from March 20 to 22 at Alexandra Headlands.

MAKING A DIFFERENCE IN THE FESTIVE SEASON

And here is more proof that the Coolum Beach's richest assets is its human capital, so much of it bonded together with blood ties and a love of testing their skills out in the surf.

Patrolling member Emma Rahui said the fun, family day out, that most holidaymakers enjoy at Coolum Beach, would have been very dangerous if it wasn't for the volunteer lifesavers. "There would have been trouble yesterday if we hadn't been here," she said.

"It was a bit hectic — there was some flash rips popping up and there was a gutter at low tide and people get stuck and they can't find their feet." Emma, her husband Terii and their son Locki regularly volunteer on the Christmas Day patrol but have gone above and beyond this year. Volunteering on both Christmas and Boxing Day the family said they love spending the day giving back.

"We don't mind, we are quite an active family so to come down and be with our friends and give back is great," Mrs Rahui said. "We are from New Zealand and we don't have family here and the surf club is kind of our family, so it makes sense that we come down here and hang out." Locki, 13, said the

unstable conditions meant he had to use his recently learnt skills. "It's my first year of patrols and I did my first rescue with a tube yesterday (Christmas) and mum did three." he said.

Holiday-maker Matt Tubb said the lifesavers gave him "piece of mind" that his family was safe. "It's awesome just to know that these guys are watching over us," he said. "It's one of those thankless jobs and it's a credit to them because they are out on Christmas Day and Boxing Day when everyone else is having a holiday and they are down here helping."

Coolum Beach Boxing Day patrol captain Jarod Sweetman said with challenging conditions over the Christmas period the lifesavers were focused on prevention. "The surf conditions have been a little bit challenging but other than that the suns been out and there have been no rescues which is good," he said. "We always focus on prevention and everyone's done the right thing and kept in close which is good."

TRAINING THE NEW RECRUITS

The work of training up new patrol members, so the volunteering gene pool stays strong going into our second century, is a task that just like the beach tides, can never stand still. In February the club proudly reported that after one Sunday of skills testing, saw "six of our newest volunteer patrol recruits complete their Surf Rescue Certificate assessment".

The SRC provides the skills and knowledge of basic patrolling and surf awareness in order to carry out water safety for Nippers but also standing down by the red and yellow flags. Our Facebook said: "A warm Coolum Beach welcome to – Alana B, Carolyn B, Ross B, Leaf B, Tim E, Nicholas P."

None of this would happen without the our dedicated trainers and assessors

The Under 19 girls' surfboat team are quickly building a reputation as a force out on the water and a positive force on the beach during patrols. Recently they did a make-up patrol on Peter Gardiner's team five and he was impressed by their willingness to join in by the flags rather than just make up the numbers.

"They were really keen to help out and stick together by the water. One was from the Gold Coat and fairly new to surf boats, learning the ropes, but loving the challenge. Another I think was a Brisbane river rower who was right into her new calling. I'd have them back anytime," Peter said.

This comes as they have been aiming high as part of a strong Coolum Beach surf boat team of rowers as they and the Under 23 girls and the Reserve Grade Men battled it out at Mollymook fourday ASRL event earlier in the season in 6-8 ft surf. The Reserve Grade men made it through to Sunday finals with the girl's

crews having no luck on the massive shore break. The Coolum Beach Under 23 crew was the only Queenslanders left in this division at final time finishing in the top 16 out of more than 60 crews.

In February in round 2 of the Qld ASRL at Maroochydore, Coolum Beach for the first time in some time fielded an A Grade men's crew in good conditions with a 3-4-foot wave on the back bank. The U19 girls were also keen to get back into the swing of things and try and prove to a few selectors that leaving them out of the Queensland team selection trails was a mistake. Our U23 girls could not row due to one rower being overseas.

The A grade men had a solid start with a close 4th in the first race, but a sweep oar broke while surfing a wave in the second race which cost a second place or first place. They finished 5th on points, but the good news is that the crew had plenty of speed and turned a few heads with their performance in A Grade ... watch this space.

As the boaties tell it: "The U19 girls had a great day of racing – over the four races they finished with three 2nd and one 1st to just miss out on winning the carnival on points. The two seconds were very close so there was a little bit of disappointment from the crew. Otherwise the girls are quick and looking strong for the remainder of the season."

In Round 3 of the ASRL at Dickies Beach on February 29, Coolum Beach's three crews gave it their all ahead of the state titles. The club online review: "Our Reserve crew rowed in the Open Men's division performing well to make it to the semi-finals. In the lady's crews our Under 19s and Under 23 crews competed well and were unlucky to not make the final rounds."

IN THE BOARDROOM

And where there are boaties, there are usually waves ... and where there are waves there is usually Coolum Beach club surfies like Bruce Dunne and Patty Lynch, who are the senior role models of a swell pulse of talented youth and now the best of rivals.

At the recent state board-riding championships held at Alexander Headland our surfers thrived in the "very contestable 2-3 foot swell". Bruce dominated the longboard section winning the 40 + age group and coming in fourth in the open. Patty Lynch, who came second in the longboard, turned it all around in the 40+ shortboard with Lynch winning that section and Dunne coming a close second for most of the final. He then had to settle for third place after Michael Landon got a great wave right at the end.

Bruce's always upbeat wife Heidi showed class and style to win bronze in the women's longboard and powered on in the short board for fourth in the women's final. Kye Atkinson displayed a powerful style for bronze in the Under 19 final after that winning wave eluded him to surf to his full potential.

As the club's Facebook summed up the contest: "Two rising stars to keep an eye on in the future is Lachlan Andrews and Brisa Soares Canina who showed tremendous surfing ability. Lachlan winning convincingly the Under 15 male shortboard and Brisa gaining a Bronze in Under 11 female shortboard.

And so to the Coolum Beach Club Championships; close to thirty athletes ranging from 13 years to 60+ fiercely competed for the age group trophies recently at the beach and water Club

BRANCH CHAMPIONSHIPS


