- Does the entity expect that it will continue to have the current level of net operating cash flows for the time being and, if not, why not?

Answer: No, cash outflows from investing activities included the payment of drilling and related services as a result of a drilling campaign undertaken.

Lefroy Exploration Limited does not expect to have the same level of net operating cash outflows going forward, as it is not expecting to undertake the same level of drilling activity within each of the next 2 quarters.

Factoring in the above, Lefroy Exploration Limited believes it has cash available for future operating activities is in excess of 2 quarters of net cash outflows for relevant outgoings going forward.

- Has the entity taken any steps, or does it propose to take any steps, to raise further cash to fund its operations and, if so, what are those steps and how likely does it believe that they will be successful?

Answer: The Company is in the process of finalising its Research and Development tax incentive program submission, relating to research activities performed by the Company on the Burns project during FY23.. It is anticipated that this rebate will be received by 30 June 2024 and provide additional funding for operational and investing activities going forward.
