Lefroy Exploration Limited (“Lefroy” or “the Company”) attaches an amended “September 2025 Quarterly Cashflow Report”.

Whilst the closing cash position at Item 4.1 “Year to date” was correct, the “Current quarter” column included a transposition error at Item 4.1, resulting in an overstatement of cash and cash equivalents at Item 4.6 and an overstatement in reconciliation of cash and cash equivalents in Items 5.1 and 5.5, flowing into section 8. Subsequently, Item 8.7 “Estimated quarters of funding available” has been revised down from 2.97 to 2.18.

All other details remain the same.
