1. Does the entity expect that it will continue to have the current level of net operating cash flows for the time being and, if not, why not?

Answer:

No, cash outflows from investing activities included the payment of drilling and related services as a result of drilling campaigns at the Burns prospect undertaken in the quarter. Lefroy Exploration Limited does not expect to have the same level of net operating cash outflows going forward, as it is not expecting to undertake the same level of drilling activity within the next 2 quarters. Lefroy Exploration Limited is also actively considering all options to extract value from the Red Dale and Lucky Strike Gold Deposits

Factoring in the expected decline in net operation cash out flows outlined above, and the potential commercialisation of the Red Dale and Lucky Strike prospects, Lefroy Exploration Limited believes it's cash available for future operating activities is in excess of 2 quarters of net cash outflows for relevant outgoings going forward.
